## SENATE BILL

AN ACT

RELATING TO PUBLIC EDUCATION; REQUIRING THAT EACH SCHOOL DISTRICT EMPLOY A MINIMUM OF ONE FULL-TIME SCHOOL NURSE; PROVIDING EXCEPTIONS; PROVIDING RULEMAKING AUTHORITY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

SECTION 1. A new section of the Public School Code is enacted to read:

"[NEW MATERIAL] MANDATORY SCHOOL NURSE--WAIVER--RULEMAKING AUTHORITY.--

- Α. Each school district shall employ a minimum of one full-time school nurse each school year, unless the department has granted the school district a waiver pursuant to Subsection B of this section.
- The department may grant a waiver to a rural school district with fewer than two hundred fifty MEM that is:

## "22-8-9. BUDGETS--MINIMUM REQUIREMENTS.--

- A. An operating budget for a school district shall not be approved by the department if the educational plan does not provide for:
- (1) a school year and school day as provided in Section 22-2-8.1 NMSA 1978; [and]
- (2) a pupil-teacher ratio or class or teaching load as provided in Section 22-10A-20 NMSA 1978; and
- (3) employment of a full-time school nurse as defined in Section 1 of this 2021 act at the school district unless a waiver has been granted as provided in Section 1 of this 2021 act.
- B. The department shall, by rule, establish the requirements for an instructional day, the standards for an instructional hour and the standards for a full-time teacher and for the equivalent thereof.
- C. As used in this section, "school nurse" means a
  person who:
- (1) is a nurse authorized pursuant to the Nursing Practice Act to practice as a professional registered nurse;
- (2) is licensed by the department and the board of nursing as a school nurse; and
- (3) provides services as a school nurse at a school."

SECTION 3. EFFECTIVE DATE.--The effective date of the provisions of this act is July 1, 2021.
