AN ACT

RELATING TO STATE AGENCIES; PROVIDING NEW SUNSET DATES FOR
CERTAIN AGENCIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

SECTION 1. A new Section 9-15-51.1 NMSA 1978 is enacted
to read:

"9-15-51.1. [NEW MATERIAL] TERMINATION OF AGENCY LIFE--
DELAYED REPEAL.--The office of military base planning and
support and the military base planning commission are
terminated on July 1, 2027 pursuant to the provisions of the
Sunset Act. The office and the commission shall continue to
operate according to the provisions of Sections 9-15-48 through
9-15-51.1 NMSA 1978 until July 1, 2028. Effective July 1,
2028, Sections 9-15-48 through 9-15-51.1 NMSA 1978 are
repealed."

5 July 1, [~~2021~~] 2027 pursuant to the Sunset Act. The board
6 shall continue to operate according to the provisions of the

8 Effective July 1, [~~2022~~] 2028, the Nutrition and Dietetics

17 Effective July 1, [~~2022~~] 2028, the Professional Psychologist
18 Act is repealed."

19 **SECTION 4.** Section 61-9A-30 NMSA 1978 (being Laws 1993,
20 Chapter 49, Section 30, as amended) is amended to read:

21 "61-9A-30. TERMINATION OF AGENCY LIFE--DELAYED REPEAL.--
22 The counseling and therapy practice board is terminated on July
23 1, [~~2021~~] 2027 pursuant to the provisions of the Sunset Act.
24 The board shall continue to operate according to the provisions
25 of the Counseling and Therapy Practice Act until July 1, [~~2022~~]

14 The board of examiners for occupational therapy is terminated
15 on July 1, [~~2021~~] 2027 pursuant to the provisions of the Sunset
16 Act. The board shall continue to operate according to the
17 provisions of the Occupational Therapy Act until July 1, [~~2022~~]
18 2028. Effective July 1, [~~2022~~] 2028, the Occupational Therapy
19 Act is repealed."

20 SECTION 7. Section 61-12B-16 NMSA 1978 (being Laws 1984,
21 Chapter 103, Section 17, as amended) is amended to read:

22 "61-12B-16. TERMINATION OF BOARD--DELAYED REPEAL.--The
23 advisory board of respiratory care practitioners is terminated
24 on July 1, [~~2021~~] 2027 pursuant to the Sunset Act. The board
25 shall continue to operate according to the provisions of the

6 The massage therapy board is terminated on July 1, [~~2021~~] 2027
7 pursuant to the provisions of the Sunset Act. The board shall
8 continue to operate according to the provisions of the Massage
9 Therapy Practice Act until July 1, [~~2022~~] 2028. Effective July
10 1, [~~2022~~] 2028, Chapter 61, Article 12C NMSA 1978 is repealed."

11 SECTION 9. Section 61-12D-17 NMSA 1978 (being Laws 1997,
12 Chapter 89, Section 17, as amended) is amended to read:

13 "61-12D-17. TERMINATION OF AGENCY LIFE--DELAYED REPEAL.--
14 The physical therapy board is terminated on July 1, [~~2021~~] 2027
15 pursuant to the Sunset Act. The board shall continue to
16 operate according to the provisions of the Physical Therapy Act
17 until July 1, [~~2022~~] 2028. Effective July 1, [~~2022~~] 2028, the
18 Physical Therapy Act is repealed."

19 SECTION 10. Section 61-14B-25 NMSA 1978 (being Laws 1996,
20 Chapter 57, Section 25, as amended) is amended to read:

21 "61-14B-25. TERMINATION OF AGENCY LIFE--DELAYED REPEAL.--
22 The speech-language pathology, audiology and hearing aid
23 dispensing practices board is terminated on July 1, [~~2021~~] 2027
24 pursuant to the Sunset Act. The board shall continue to
25 operate according to the provisions of the Speech-Language
