AN ACT

MAKING AN APPROPRIATION TO THE INDIAN AFFAIRS DEPARTMENT FOR
LIBRARY AND EDUCATIONAL RESOURCE CENTER PROJECTS FOR INDIAN
NATIONS, TRIBES AND PUEBLOS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

SECTION 1. APPROPRIATION.--

A. An aggregate total of eighty-nine million three
hundred sixty-one thousand nine hundred forty-two dollars
(\$89,361,942) is appropriated from the general fund to the
Indian affairs department for expenditure in fiscal years 2023
through 2026 for the following purposes:

(1) sixty-six million six hundred eighty-two
thousand nine hundred forty-two dollars (\$66,682,942) to plan,
design, renovate, expand, construct, equip and furnish
libraries and education centers statewide for Indian nations,

9 B. Any unexpended or unencumbered balance of an
10 appropriation made for a project pursuant to this section shall
11 revert to the tribal infrastructure project fund within six
12 months of completion of the project, but no later than fiscal
13 year 2026.
