12	ENVIRONMENT TO COORDINATE THE STATE'S EFFORTS TO CLEAN UP AND
13	RECLAIM FORMER URANIUM MINE AND MILL SITES; PROVIDING DUTIES;
14	CREATING THE URANIUM MINING RECLAMATION REVOLVING FUND; MAKING

17	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
18	SECTION 1. [<u>NEW MATERIAL</u>] URANIUM MINING RECLAMATION
19	DEPARTMENT OF ENVIRONMENTDUTIES
20	A. The department of environment shall:
21	(1) coordinate the state's efforts to clean up
22	and reclaim former uranium mine and mill sites and undertake
23	uranium mine and mill site reclamation projects. The energy,
24	minerals and natural resources department; the Indian affairs
25	department; the office of natural resources trustee; the state

8 develop a strategic plan for the cleanup (2) 9 of uranium mine and mill sites throughout the state, including 10 reclamation goals, time lines for the completion of cleanup 11 activities at specific sites and anticipated funding 12 requirements. The department of environment shall consult with 13 the departments and agencies enumerated in Paragraph (1) of 14 this subsection in the development of the strategic plan and 15 include in the strategic plan the respective agencies' and 16 departments' input;

(3) establish an effective mechanism for consultation and coordination with the federal government; Indian nations, tribes and pueblos; communities impacted by uranium mining; and other states on uranium mine and mill reclamation activities;

(4) work with the economic development department, workforce solutions department and industry to establish uranium mine and mill reclamation as a target economic development industry in New Mexico, including the .221293.8 - 2 -

1 creation, coordination and promotion of worker training and 2 business development programs for reclamation activities; 3 develop, maintain and update on a regular (5) 4 basis a centralized repository of uranium mine and mill sites 5 and reclamation activities. The repository shall include, at minimum, the location of uranium mine and mill sites, 6 7 information about the ownership and legal jurisdiction of each 8 site and each site's cleanup status; and 9 on an annual basis, report to the (6) 10 radioactive and hazardous materials committee on the department 11 of environment's activities in the preceding year. The 12 department of environment shall consult with the departments 13 and agencies enumerated in Paragraph (1) of this subsection and 14 include in the report the activities undertaken by the 15 respective departments and agencies in the preceding year that 16 are related to uranium mine and mill site reclamation. 17 Β. The secretary of environment shall create a 18 uranium mine reclamation coordinator position and employ 19 additional staff as needed for the department of environment to 20 carry out the provisions of this section. 21 SECTION 2. [NEW MATERIAL] URANIUM MINING RECLAMATION 22 REVOLVING FUND--CREATED.--23 The "uranium mining reclamation revolving fund" Α. 24 is created in the state treasury. The uranium mining 25 reclamation revolving fund consists of appropriations, gifts, .221293.8

underscored material = new [bracketed material] = delete grants, donations and money received by the department of environment from the federal government or other state agencies and other sources for conducting uranium mine and mill reclamation activities. Money recovered for the state by or on behalf of the department of environment from uranium mine or mill reclamation related litigation or settlements shall be deposited in the uranium mining reclamation revolving fund.

8 Subject to legislative appropriation, Β. 9 expenditures may be made from the uranium mining reclamation 10 revolving fund upon vouchers signed by the secretary of 11 environment, or the secretary's designee, and warrants issued 12 by the secretary of finance and administration for the 13 department of environment to undertake projects to reclaim 14 uranium mine and mill sites, including the acquisition of tools 15 and equipment; expenses incurred by the department of 16 environment in planning, supervising and completing uranium 17 mine and mill reclamation projects; and expenses incurred in 18 litigation involving uranium mine or mill sites; provided that money in the fund shall not be used for the operational 20 expenses of the department of environment.

Money in the uranium mining reclamation C. revolving fund shall not revert to the general fund at the end of a fiscal year.

SECTION 3. APPROPRIATION. -- Three hundred fifty thousand dollars (\$350,000) is appropriated from the general fund to the .221293.8
