SENATE HEALTH AND PUBLIC AFFAIRS COMMITTEE SUBSTITUTE FOR  
SENATE BILL 500

**56TH LEGISLATURE - STATE OF NEW MEXICO - FIRST SESSION, 2023**

AN ACT

RELATING TO THE PUBLIC PEACE, HEALTH, SAFETY AND WELFARE;  
REQUIRING A SPACE ON LICENSE APPLICATION AND LICENSE RENEWAL  
FORMS FOR APPLICANTS TO STATE A DESIRE TO MAKE AN ANATOMICAL  
GIFT; REQUIRING THE MOTOR VEHICLE DIVISION OF THE TAXATION AND  
REVENUE DEPARTMENT TO MAINTAIN APPLICATIONS WITH THOSE  
COMPLETED STATEMENTS IN A STATEWIDE DONOR REGISTRY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

SECTION 1. A new section of Chapter 17, Article 3 NMSA  
1978 is enacted to read:

"[NEW MATERIAL] DONOR REGISTRY.--

A. In addition to other requirements established  
for a blank application furnished by the director of the  
department of game and fish pursuant to Section 17-3-5 NMSA  
1978, the director shall include on each blank application a

1 space to show whether the applicant is a donor as provided in

3 B. The applicant may indicate the applicant's donor  
4 status on the space provided on the application if the

6 on an application form for a driver's license pursuant to  
7 Section 66-5-10 NMSA 1978. If the applicant desires to be a  
8 new donor, the form shall be signed by the donor in the  
9 presence of a witness who shall also sign the form in the  
10 donor's presence.

11 C. The director of the department of game and fish  
12 shall, by January 1, 2024, include the following donor  
13 statement on each license application form:

 3 person who wishes to be a donor to the division.

4 E. The division shall maintain each application it  
 5 receives from a license vendor pursuant to this section in the  
 6 statewide donor registry that it maintains pursuant to Section  
 7 66-5-10 NMSA 1978. Authorized hospital or organ and tissue  
 8 donor program personnel, immediately prior to or after a  
 9 donor's death, may request verification of the donor's status  
 10 from the division and may obtain a copy of the application from  
 11 the division.

12 F. For the purposes of this section, "division"  
 13 means the motor vehicle division of the taxation and revenue  
 14 department."

15 SECTION 2. A new section of the Concealed Handgun Carry  
 16 Act is enacted to read:

17 "[NEW MATERIAL] DONOR REGISTRY.--

18 A. The department shall include on any concealed  
 19 handgun license application form or concealed handgun license  
 20 renewal application form a space to show whether the applicant  
 21 is a donor as provided in the Jonathan Spradling Revised  
 22 Uniform Anatomical Gift Act.

23 B. The applicant may indicate the applicant's donor  
 24 status on the space provided on the application if the  
 25 applicant has not already marked the applicant's donor status

22 application form that has a completed donor statement to the  
23 division.

25 receives from the department pursuant to this section in the

 2 66-5-10 NMSA 1978. Authorized hospital or organ and tissue  
 3 donor program personnel, immediately prior to or after a  
 4 donor's death, may request verification of the donor's status  
 5 from the division and may obtain a copy of the application from  
 6 the division.

7 F. For the purposes of this section, "division"  
 8 means the motor vehicle division of the taxation and revenue  
 9 department."

10 SECTION 3. Section 29-19-5 NMSA 1978 (being Laws 2003,  
 11 Chapter 255, Section 5, as amended) is amended to read:

12 "29-19-5. APPLICATION FORM--SCREENING OF APPLICANTS--  
 13 FEE--LIMITATIONS ON LIABILITY.--

14 A. [~~Effective July 1, 2003~~] Applications for  
 15 concealed handgun licenses shall be made readily available at  
 16 locations designated by the department. Applications for  
 17 concealed handgun licenses shall be completed, under penalty of  
 18 perjury, on a form designed and provided by the department and  
 19 shall include:

20 (1) the applicant's name, current address,  
 21 date of birth, place of birth, social security number, height,  
 22 weight, gender, hair color, eye color and driver's license  
 23 number or other state-issued identification number;

24 (2) a statement that the applicant is aware  
 25 of, understands and is in compliance with the requirements for

1 licensure set forth in the Concealed Handgun Carry Act;

2 (3) a statement that the applicant has been  
3 furnished a copy of the Concealed Handgun Carry Act and is  
4 knowledgeable of its provisions; ~~and~~

5 (4) a conspicuous warning that the application  
6 form is executed under penalty of perjury and that a materially  
7 false answer or the submission of a materially false document  
8 to the department may result in denial or revocation of a  
9 concealed handgun license and may subject the applicant to  
10 criminal prosecution for perjury as provided in Section 30-25-1  
11 NMSA 1978; and

12 (5) a space, as required by Section 2 of this  
13 2023 act, to show whether the applicant is a donor as provided  
14 in the Jonathan Spradling Revised Uniform Anatomical Gift Act.

15 B. The applicant shall submit to the department:

16 (1) a completed application form;

17 (2) a nonrefundable application fee in an  
18 amount not to exceed one hundred dollars (\$100);

19 (3) two full sets of fingerprints;

20 (4) a certified copy of a certificate of  
21 completion for a firearms training course approved by the  
22 department;

23 (5) two color photographs of the applicant;

24 (6) a certified copy of a birth certificate or  
25 proof of United States citizenship, if the applicant was not

1 born in the United States; and

2 (7) proof of residency in New Mexico.

3 C. A law enforcement agency may fingerprint an  
4 applicant and may charge a reasonable fee.

5 D. Upon receipt of the items listed in Subsection B  
6 of this section, the department shall make a reasonable effort  
7 to determine if an applicant is qualified to receive a  
8 concealed handgun license. The department shall conduct an  
9 appropriate check of available records and shall forward the  
10 applicant's fingerprints to the federal bureau of investigation  
11 for a national criminal background check. The department shall  
12 comply with the license-issuing requirements set forth in  
13 Section 29-19-7 NMSA 1978. However, the department shall  
14 suspend or revoke a license if the department receives  
15 information that would disqualify an applicant from receiving a  
16 concealed handgun license after the thirty-day time period has  
17 elapsed.

18 E. A state or local government agency shall comply  
19 with a request from the department pursuant to the Concealed  
20 Handgun Carry Act within thirty days of the request."

21 SECTION 4. A new section of the Uniform Licensing Act is

 7 NMSA 1978. Authorized hospital or organ and tissue donor  
 8 program personnel, immediately prior to or after a donor's  
 9 death, may request verification of the donor's status from the  
 10 division and may obtain a copy of the application from the  
 11 division.

12           F. For the purposes of this section, "division"
