## **BILL SUMMARY**

Synopsis: HB11 (Paid Family and Medical Leave Act) establishes a Paid Family and Medical Leave Fund in the state treasury and provides eligible applicants with funding to support paid family and medical leave. This includes time for bonding with a new child, caring for a family member, military deployment preparation, and to protect a family member from certain violence. The bill also establishes other policy for eligibility for leave, exemptions for certain employees, and establishes the Department of Workforce Solutions (DWS) as the administrator of the fund. In addition, this bill creates a temporary advisory committee to oversee establishment and initial implementation of Paid Family and Medical Leave.

ECECD anticipates only minor fiscal implications related to this bill as the current rate structure for child care, PreK, Family Infant Toddler, and Home Visiting programs. However, the bill cites the implementation date of leave beginning in January 2028. This is likely to have a fiscal impact beginning in FY28 due to the need for additional substitutes for coverage for educators.

## ADMINISTRATIVE IMPLICATIONS

ECECD would need to ensure all child care, Family Infant Toddler, Home Visiting, and PreK providers are aware of this bill's requirements and would do so in partnership with DWS.

# CONFLICT, DUPLICATION, COMPANIONSHIP, RELATIONSHIP

Relationship: Currently, families across New Mexico are able to access care for their infant starting at age six weeks. This bill would support families in caring for children in the time where no licensed child care is available (0-6 weeks) and ongoing during infancy and for other child health related issues. At this time, there is a lack of infant care across the state and infants are the most underserved group of children in ECECD's programs. This is especially of concern because secure attachment/stable caregiver relationships are most impactful on development in the earliest weeks of life. In addition, licensed child care programs must exclude children when they are ill, meaning that this bill would also serve to address that gap in care.
