1. BILL SUMMARY

a) Synopsis

HB 40 seeks to require some public accessed buildings to have at least one universal adult changing station that is accessible to all genders when the facility is open to the public. Venues would include venues of public amusement (auditoriums, convention centers, cultural complexes, an exhibition halls, sports areas, permanent amusement parks, theatres, and movie houses) for which a maximum capacity is two thousand five hundred (2500) people. HB40 also includes a definition for "covered facility", which means a public building or commercial place of public amusement that (a) houses an entity or program that receives state funding to cover any portion of the entity or program's operating costs; and (b) receives at least two thousand five hundred visitors per year, as measured by the tourism department.

b) Significant Issues

HB 40 would ensure that people living with disabilities requiring the use of continence care products have a safe, secure, and sanitary location to assist them and their caregivers with the changing of the products. While these systems are often labeled "adult changing stations", they are also a great tool for parents who have older children that no longer fit on the smaller changing stations.

The average cost to remodel an existing table can cost up to \$14,000. This amount is impacted by the type of device selected and the cost of installation. (https://marylandmatters.org/2024/10/14/more-restrooms-have-adult-size-changing-tables-to-help-people-with-disabilities/)

Key points about adult changing stations:

- Accessibility: They are designed to accommodate larger individuals and provide features like adjustable height and side rails, making it easier for caregivers to assist with changing needs.
- Hygiene: Changing on a designated surface instead of the floor significantly improves sanitation and reduces the risk of infection.
- Sanitation: Sanitation concerns related to adult changing stations would be similar to a baby changing station where individuals utilizing them, and businesses ensure general cleanliness.
- Dignity: Providing a dedicated space for changing can contribute to a more respectful and comfortable experience for the person needing assistance.
- Community participation: By enabling individuals with disabilities to access public spaces more easily, adult changing stations can help them participate in social activities and travel freely.
