#### **BILL SUMMARY**

Synopsis: AED "automated external defibrillator" means a medical device heart monitor and defibrillator that is capable of recognizing cardiac arrest that will respond to defibrillation, ventricular fibrillation or rapid ventricular tachycardia and is capable of determining whether defibrillation should be performed; and upon determining that defibrillation should be performed, automatically charges and is capable of delivering an electrical impulse to an individual's heart.

#### **SIGNIFICANT ISSUES**

A mainstay and recognized intervention for sudden cardiac emergencies, AED is widely available in a preponderance of public facilities. Out of hospital intervention is feasible and desirable.

#### PERFORMANCE IMPLICATIONS

CPR Training access in smaller communities with limited options may require an initial instructor identification and training process, followed by re-training. This is a widespread community skill in many facilities. It is easy to implement and maintain with a dedicated process.

#### **ADMINISTRATIVE IMPLICATIONS**

Routine checking of device function, regular device maintenance, checking expiration of AED pads, securing the device to prevent tampering, and documentation in a log.

# CONFLICT, DUPLICATION, COMPANIONSHIP, RELATIONSHIP

#### **TECHNICAL ISSUES**

Awareness of AED pad acquisition based on consistent AED models may be more economical. Low utilization may require thoughtful ordering and centralization to prevent waste of unused replacement pads.
