#### 1. BILL SUMMARY

#### a) Synopsis

House Bill 0072 (HB72) proposes to create a committee that will determine the necessary staffing ratios for a hospital and hospital unit (both defined in HB72) in New Mexico. The committee would consist of 11 people with the ability to create rules that hospitals must remain in compliance with. Failure to comply with these rules would subject hospitals to escalating fines. The bill is aimed mostly at nurses and licensed professionals in hospitals, but also unlicensed personnel in hospital units. The ratios determined by the committee would immediately apply to hospitals.

# b) Significant <u>Issues</u>

• The intent of the bill is to apply to emergency departments and other physical health hospitals, but it would apply to the Forensic and Civil divisions of New Mexico Behavioral Health Institute (NMBHI), the Medical Rehabilitation Unit (MRU) side of New Mexico Rehabilitation Center (NMRC), and to Turquoise Lodge Hospital (TLH). The bill proposes one set of ratios that would apply to every hospital in the state, including those operated by NMDOH.

- In the definition section, "hospital" was changed and may be broadly interpreted to include long-term care and skilled nursing facilities, which is not the intent of the bill. The definition should be amended to eliminate the possibility of this confusion.
- Hospitals in NM, and throughout much of the country, have faced significant and consistent staffing challenges in recent years, which affect administrators' assessment of safe management of census. NMBHI receives many patients through court order. This bill would create a situation in which NMBHI could be court ordered to provide treatment without adequate staff or funding to hire new staff to meet required ratios. NMBHI does not receive revenue for the care of patients at the Forensic Unit or Adult Psych, relying exclusively on general fund for the cost of administering care.
- If NMBHI cannot admit people, the Department may be open to show cause hearings and other legal proceedings.
- NMBHI has historically faced a larger number of complaints regarding people not being

| •          | admitted in a timely manner than complaints regarding staffing ratios.  The federal government has proposed ratios for nursing homes, however state and federal agencies have traditionally not been prescriptive in the ratios of staff to patients, mostly because hospitals that are licensed similarly may serve very different populations.  These proposals would impact the Healthcare Authority (HCA), as the HCA would have to enforce the ratios.  This bill was introduced during the 2024 session and did not pass. |
