SECTION III: NARRATIVE

BILL SUMMARY

The bill would add clarifying language specifying the section's applicability to: negligent arson victims who suffered bodily harm, both voluntary and involuntary manslaughter victims' survivors, and modifying the use of the word "abandonment" to clarify that <u>child</u> abandonment is the crime referenced in the bill. The bill also makes a grammatical edit eliminating the use of the word "a" as a grammatical article.

The most substantive changes are the additions of three crimes perpetrated against peace officers to the list of crimes in the Victims of Crime Act: aggravated assault, assault, and battery. The significance of the addition of these crimes is that the bill would confer legal rights on peace officer crime victims, such as the right to be present in court at all legal proceedings, and the right to receive notification of events in the cases in which they are victims. As a matter of practice, NM Crime Victims Reparations Commission (CVRC) already provides victim compensation assistance to injured peace officers since the compensation statutes do not foreclose this aid and CVRC's mission is to serve all crime victims.

Synopsis:

The bill makes some language edits to existing law and provides crime victim legal rights to peace officers who are victims of Aggravated Assault on a Peace Officer, Assault on a Peace Officer, and Battery on a Peace Officer.
