#### **BILL SUMMARY**

Synopsis: HB 107 Imposes criminal sentencing and fines for trafficking of a controlled substance that results in the death of a human being, and includes counterfeits of certain controlled substances in the definition of "traffic."

Imposes the following sentences:

- For the first offense of trafficking a controlled substance, a second degree felony with a minimum term of nine years' imprisonment
- For the first offense of trafficking a controlled substance resulting in the death of a human being, a second degree felony with a minimum term of 12 years' imprisonment, plus a possible fine of up to \$12,500.
- For second and subsequent offenses of trafficking a controlled substance resulting in the death of a human being, a first degree felony with life imprisonment and a possible fine of up to \$17,500.
- Distribution to a minor of a Schedule I or II controlled substance that is a narcotic or analog, or of methamphetamine or its analog, is a first degree felony of 18 years.

Includes in the definition of "traffic" in the Controlled Substances Act a counterfeit substance of a Schedule I or II narcotic drug, and a counterfeit substance of a controlled substance analog of a Schedule I or II narcotic drug
