SECTION III: NARRATIVE

BILL SUMMARY

House Bill 127 appropriates \$1,000,000 from the general fund to the Department of Public Safety for the purchase of license plate readers. The funds are allocated for expenditure during fiscal year 2026, with any unspent or unencumbered balance reverting to the general fund at the end of the fiscal year. This legislation aims to enhance public safety by equipping law enforcement with technology to monitor and identify vehicles effectively.

FISCAL IMPLICATIONS

Currently, the LPR system being deployed by NMDPS for a two-camera setup costs around \$10,306, which includes one year of software licensing and warranty. The installation cost is about \$30,000, bringing the total cost for each deployment to approximately \$40,306. Based on these figures, this appropriation could fund around 24 two-camera systems, though allocating some funds for licensing may reduce that number by one or two systems.

With the addition of these 24 systems, NMDPS will have a total of about 112 LPR camera systems statewide, which would significantly enhance public safety and DPS operations. The New Mexico Department of Public Safety (DPS) will incur a recurring annual cost of approximately \$50,400 for the maintenance of 24 new license plate reader (LPR) camera systems.

SIGNIFICANT ISSUES

None at this time.

PERFORMANCE IMPLICATIONS

The funding provided in this bill would allow DPS to significantly expand the footprint of our current statewide LPR program. This would allow for the more effective use of law enforcement resources and result in a sizeable increase in the detection of criminal activity on our highways. DPS is very supportive of this bill as it will help improve public safety in the state. Also, law enforcement agencies who possess sharing agreements with DPS will be able to utilize the info for their investigatory purposes as well, which is very beneficial.
