# SECTION III: NARRATIVE

### **BILL SUMMARY**

#### Synopsis:

An addition to the Delinquency Act establishing the purchase, possession, receipt, production, or use of cannabis, or presence in a cannabis retail establishment as a "delinquent act." There is an exception for the use of medicinal cannabis and an exception for being present in a cannabis retail establishment with a parent or adult spouse.

# **FISCAL IMPLICATIONS**

Although there are no appropriations associated with this bill, it could potentially increase caseloads in juvenile and criminal court. An increase in case load without a commensurate increase in appropriations may lead to budget shortfalls, delays in processing cases, and failure to provide adequate legal representation.

Even with increased caseloads in juvenile and criminal court, this bill would not likely have a fiscal impact on the Office of Family Representation and Advocacy (OFRA).

## SIGNIFICANT ISSUES

This bill could result in more children being incarcerated and children being incarcerated for longer durations. Increasing detention of children destabilizes the futures of those children, their families, and their communities.

This bill amends an act that is also the subject of another bill, HB 134.

#### **TECHNICAL ISSUES**

It is already a "delinquent act" for a minor to be present in a liquor establishment without a parent, or to purchase, receive, or use alcohol (page 2, line 13). The bill deletes his current section regarding alcohol and creates a new section regarding the same issue (page 3, line 21). The new section has confusing, if not contradictory, language at page 3,

lines 23-24. This confusing language could be clarified by changing the language to say any of the following are delinquent acts: "[A]ttempting to buy, receiving, possessing or being served any alcoholic liquor or *being present in a licensed liquor establishment*, other than a restaurant or a licensed retail liquor establishment, when not in the presence of the child's parent, guardian, custodian or adult spouse."

The confusion could also be eliminated by defining (and thereby more clearly distinguishing between) the terms "licensed liquor establishment" and "licensed retail liquor establishment."
