#### **SECTION III: NARRATIVE**

#### **BILL SUMMARY**

<u>Synopsis:</u> House Bill 209 (HB 209) would create a new provision under Section 10-16D-3 NMSA 1978 which would require DoIT to post links to the New Mexico compilation commission's website for each state fund created by law that connect the users of the New Mexico Sunshine Portal directly to the statutory provision that created the fund.

## **FISCAL IMPLICATIONS**

DoIT estimates that it would cost approximately \$50,000 to make the initial updates to the Sunshine Portal that would be required to comply with this legislation. After the initial configuration, DoIT should be able to maintain and update the links as changes are made to legislation affecting state funds through DoIT's regular operating budget.

#### SIGNIFICANT ISSUES

DoIT does not have the resources or expertise to properly identify all of the laws that create state funds. DoIT can post the links to the laws, if those links are identified by Compilation Commission staff, legislative staff, or other entity with sufficient expertise to properly identify the links.

Since this bill does not have an effective date specified, it would go into effect before the new fiscal year. Since new funds would be required to complete the initial configuration, DoIT would ask for an effective date of December 2025, to give time for funding to be released and encumbered with DoIT's vendor who maintains the Sunshine Portal, in fiscal year 2026.

## **PERFORMANCE IMPLICATIONS**

## **ADMINISTRATIVE IMPLICATIONS**

DoIT has a contract with a vendor to maintain the Sunshine Portal. Without sufficient appropriations to compensate the vendor for the costs associated with the initial configuration required to comply with this legislation, the administrative impact on DoIT would be extremely burdensome.
