BILL SUMMARY

Synopsis:

HB 248 creates a new crime, unlawful carrying of a firearm while trafficking a controlled substance, which consists of carrying a firearm while violating the provisions of Section 30-31-20 NMSA 1978 (the trafficking of controlled substances statute). Whoever commits unlawful carrying of a firearm while trafficking a controlled substance is guilty of a third degree felony.

SIGNIFICANT ISSUES

The Sentencing Commission looked at cases filed and people incarcerated at present for a violation of Section 30-31-20 NMSA 1978, trafficking a controlled substance. There were 1,620 cases filed on or after July 1, 2023 that had a violation of Section 30-31-20 as the lead offense. This includes cases that are pending/not yet disposed. There were 223 people incarcerated with a lead offense statute of Section 30-31-20 that entered NMCD during FY24.

Looking at the various firearms statutes presently in the Criminal Code, Sections 30-7-1 through 30-7-4, and Section 30-7-6, there were a total of 1,056 cases filed in FY24 that had lead offense as a violation of one of these statutes. Additionally, there were a total of 87 people incarcerated in FY24 with lead offenses of 30-7-1 through 30-7-4 or 30-7-16.

It is difficult to determine what the effect of passing HB 248 would be on the state's prison population. The average per day cost to incarcerate someone in the state's prison system is \$155.63/day; this average includes private and public facilities.
