#### **BILL SUMMARY**

HB 261 employs the New Mexico State Investment Council or State Treasurer to invest funds in the Local Government Investment Pool on behalf of the regional spaceport districts.

## FISCAL IMPLICATIONS

## **SIGNIFICANT ISSUES**

This bill as written causes confusion because it can be assumed that the SIC can invest in the Local Government Investment Pool which is under the Office of the State Treasurer.

The funds within the spaceport districts should not be invested with SIC as they currently only have approximately \$21 million in which they have made a resolution to give \$13.9 million to the spaceport authority which has an account with the treasury. The State Investment Council is designed to invest funds for trusts and large sums of dollars that do not need liquidity or short term investing. Short term investing should take place with the State Treasurer's office.
