BILL SUMMARY

Synopsis:

Relating to school personnel; providing for licensure endorsement in computer science for all grades.

FISCAL IMPLICATIONS

TECHNICAL ISSUES

- 1. Should the requirements for endorsement be included in the bill's language? The reason we ask is because either (a) the language was unclear or (b) the requirements seemed inconsistent in terms of preparation. For example,
 - a. Is the itemized list that begins on page 3, line 18 a series of "or" statements? If so, then

- the language on Page 3, lines 16 and 17, should read "requires the teacher to have either:"
- b. Regarding the itemized list, the requirements seem to vary significantly in terms of experience with the computer science content. Item (1) requires 15 credits of formal coursework in computer science. This translates into 4 to 5 courses, almost enough for a minor at many institutions. This option would involve over 200 hours of in-class time and likely more than 500 hours of out of class time. While reasonable, it is significantly more than if someone decided to pursue item (5) that has individuals completing sixty hours of professional development which seems woefully short.

Therefore, do the requirements for the endorsement need to be included in the bill? If they do, then we believe the language needs to be clarified with requirements being comparable in terms of how they prepare individuals to serve as a teacher.

Other ways the language could be clarified includes what types of coursework individuals should take, what types of certifications would be deemed appropriate, etc. For example, Page 4, lines 10-13 outlines some of the relevant experience being asked of individuals seeking an endorsement. As a result, a similar restriction on the course content may also be appropriate.
