BILL SUMMARY

Synopsis: HB 336 enacts expanding the definition of peace officers who can return to work after retirement.

FISCAL IMPLICATIONS

No direct fiscal implications for the agency.

SIGNIFICANT ISSUES

HB 336 will amend the current retirement act to allow certain public safety employees to return to work. To include specialized jurisdictions of law enforcement.

PERFORMANCE IMPLICATIONS

The New Mexico Livestock Board received applications in 2024 from two retired officers wishing to take advantage of the return-to-work privileges. PERA determined that our agency, and others, did not fit into the limited definition of the act. By amending the act to include all law enforcement agencies, the NMLB will save time and money on training. The NMLB will also benefit from the amendment by being able to hire seasoned officers to guide and train current inspectors. Seasoned officers will also benefit the NM State Veterinarian in the event of a disease outbreak by providing law enforcement and investigatory experience to the occurrence.

ADMINISTRATIVE IMPLICATIONS

Savings for the agency will be realized by hiring seasoned officers and spending less time and money on training.
