SECTION III: NARRATIVE

BILL SUMMARY

House Bill 402 (HB402) adds a new section to Article 23G, the Short-Term Health Plan and Excepted Benefit Act in the Insurance Code. The new section establishes a uniform and efficient provider credentialing process for a provider of a dental plan. The bill provides a time frame for approval or denial of a credentialing application and for loading an approved provider's information into a health insurance carrier's provider payment system. HB402 provides for reimbursement to a provider if certain time frames are not met.

FISCAL IMPLICATIONS

This legislation imposes credentialing requirements for dentists, including rulemaking to provide for a uniform and efficient provider credentialing process. This will require an additional staff member to handle dental credentialing reporting, compliance reviews and related complaints. The Estimated Additional Operating Budget Impact section reflects 2 full-time Compliance Officers-A, Pay Band 65, who will perform these functions.

TECHNICAL ISSUES

The "provider" definition differs from the current definition in §59A-23G-12(A)(2) related to dental plan provider network leasing.

The bill does not establish any communication the insurer or insurer's agent must provide, such as a written notice to provider regarding approval or disapproval of the credentialing. This will need to be addressed through rulemaking.
