## **SECTION III: NARRATIVE**

#### **BILL SUMMARY**

HB 408 requires the Children, Youth, and Families Department to conduct a study every five years regarding the costs and reimbursement rates for providing community-based foster care placements and treatment. HB 408 comes with an appropriation of one hundred thousand dollars (\$100,000) from the general fund for expenditure in the fiscal year 2026. The study shall include the costs of resources to address the safety and physical and emotional well-being of a child, parent, guardian or foster parent. The study shall also include the costs of payments to reimburse resource families for food, clothing, shelter, daily supervision, school supplies, personal incidentals and travel expenses to meet the needs of a foster child in their care, and any other costs or reimbursements as identified by the department. The results of the initial study shall be provided to the legislative finance committee no later than December 1, 2025. Each additional study shall be provided no later than December 1 of the calendar year in which the study is conducted. The term resource parent also applies to treatment foster care in addition to relative foster care, non-relative foster care, and respite foster care. Resource family includes foster parents and pre-adoptive parents as defined by Section 32A-1-4. Any unexpended or unencumbered balance remaining at the end of fiscal year 2026 shall revert to the general fund. The effective date of the provisions of this act is July 1, 2025.

#### FISCAL IMPLICATIONS

Although HB 408 directs the department to conduct rate studies every five years, it only provides an appropriation to be expended in the first fiscal year. Appropriations are not secured to account for any foster care reimbursement rate increases that may be recommendations as a result of these studies.

## SIGNIFICANT ISSUES

As currently written, the bill does not provide appropriations beyond the first fiscal year of enactment even though the bill requires a rate study and report every 5 years.

#### PERFORMANCE IMPLICATIONS

If enacted, HB 408 will support CYFD in studying whether foster care comparable, appropriate, and sustainable. This reimbursement rates are bill would further support CYFD in advocating for more funding, if the results of the study recommend an increase to the foster care reimbursement rates. This would also allow the legislative finance committee to have the comprehensive study and findings every five years and would support the committee in making budget decisions. However, it is not determined in HB 408 how the department would sustain the conducting of such studies every 5 years as only the initial study with appropriation. comes an
