SECTION III: NARRATIVE

BILL SUMMARY

House Bill 459 (HB459) relates to education and research. It makes an appropriation to the New Mexico Higher Education Department (NMHED) for a program at the Institute of American Indian Arts (IAIA) for research into and education and outreach about pollinators to support a healthy habitat and conservation. HB459 is pursuant to House Memorial 33 of the second session of the fifty-sixth legislature.

FISCAL IMPLICATIONS

HB459 appropriates one million five hundred thousand dollars (\$1,500,000) from the General Fund to NMHED for expenditure in FY26-28. Any unexpended or unencumbered balance remaining at the end of FY28 shall revert to the General Fund.

SIGNIFICANT ISSUES

HB459 is for research into and education and outreach of pollinators to support a healthy habitat and conservations of pollinators in a way consistent with recommendations makes in the report prepared pursuant to House Memorial 33 (HM33) passed in the 2024 legislature and signed into law.

House Memorial 33 (HM33) was a memorial requesting the New Mexico Department of Agriculture to convene a working group to consider acceptance of a pollinator protection plan as proposed by the New Mexico Beekeepers Association and assess ways to protect pollinators through community education, an outreach and data collection.

The monies appropriated to NMHED are to be used for a program at the Institute of American Indian Arts for FY26-28 and shall be for indirect costs necessary to administer the programs.

NMHED and IAIA would need to educate themselves on the recommendations for continual assessment generated by HM33 in order to understand the expectations to work collaboratively with IAIA and to develop performance measures. HM33 requested the working work to report its recommendations to the appropriate interim legislative committees dealing with conservation and environmental issues by October 1, 2024.

PERFORMANCE IMPLICATIONS

HB459 does not outline specific performance measures; however, if funded IAIA should develop performance measures in coordination with NMHED.

ADMINISTRATIVE IMPLICATIONS

IAIA would provide the research and education and outreach for this program.

NMHED will administer these funds involving receipt, disbursement, and tracking to IAIA.
