BILL SUMMARY

Synopsis: HB 543 amends Section 24-34-2 NMSA 1978 to define a minor as an individual under the age of 18 and Section 24-34-3 NMDS 1978 to clarify that the Reproductive and Gender-Affirming Health Care Freedom Act shall not be construed to allow a minor to receive gender-affirming health care or reproductive health care without parental consent in any manner that is not otherwise provided for by law.

FISCAL IMPLICATIONS

SIGNIFICANT ISSUES

State laws governing minors' consent for health care will apply regardless of HB 543.
