#### **BILL SUMMARY**

## Synopsis:

HJR 9 looks to amended the New Mexico Constitution Article 2, Section 13. HJR adds two new factor to be proven by the State the defendant is not a flight risk or has failed to appear in Court release.

#### FISCAL IMPLICATIONS

#### **SIGNIFICANT ISSUES**

HJR 9 strike "court on the record" but leave the language of an appeal. A Court of record makes an appeal easier since there is a record of the underlying court's decision and reasons for the decision.

The way the HJR 9 is written has another factor for the prosecutors to prove by clear and convincing evidence that the defendant is a flight risk or that the defendant has not failed to appear in Court. This will lead to more defendant's being released in the community. A murder defendant could be released back into the community because he is not a flight risk or failed to appear in Court even though he is a danger to the community.
