#### **BILL SUMMARY**

Amends the Criminal Code to create the fourth degree felony of unlawful possession or transportation of a stolen firearm. Requires knowledge or reason to believe the firearm was stolen. Each firearm possessed or transported constitutes a separate offense.

#### FISCAL IMPLICATIONS

### SIGNIFICANT ISSUES

### PERFORMANCE IMPLICATIONS

Addressing the issue of stolen firearms and enhancing accountability for people who possess them will strengthen the law and improve New Mexico by making it harder for them to be circulated in illegal markets and helping to better trace and remove stolen weapons from circulation:

- 1. **Accountability for Possession of Stolen Firearms:** By making it unlawful to knowingly possess or transport a stolen firearm (or one that could reasonably be assumed to be stolen), the law will deter people from keeping firearms that aren't legally theirs. It would specifically target individuals who may try to profit from stolen firearms or use them in criminal activity, creating a stronger incentive for responsible ownership and handling of firearms.
- 2. **Separate Offense for Each Firearm:** Treating each firearm as a separate offense means that individuals found with multiple stolen firearms could face multiple charges, which could lead to more serious penalties and consequences for those engaging in firearm trafficking or illegal possession.
