Synopsis:

SB78- Nearly identical to 2023 SB80 and 2021 HB35 and SB201) Amends licensure provisions for certification as a registered nurse anesthetist in two ways: (1) changes the standard of care and services from those of the American Association of Nurse Anesthetists to the current guidelines for nurse anesthesia practice issued by the national professional association representing certified registered nurse anesthetists; and (2) authorizes a certified registered nurse anesthetist to function in either an independent role or in collaboration with other health care providers in accordance with the policies of a health care facility.
