SB104- Duplicate of 2025 HB79; almost identical to 2023 HB391 and 2021 HB210) Enters New Mexico in the Audiology and Speech-Language Pathology Interstate Compact for the purpose of facilitating interstate practice of audiology and speech-language pathology and improving public access to audiology and speech-language pathology services, including telehealth technology. The Audiology and Speech-Language Compact Commission would serve as the national administrative body.
