BILL SUMMARY

<u>Synopsis:</u> SB 159 authorizes the issuance of special independent theater dispensing licenses for beer and wine.

FISCAL IMPLICATIONS

SIGNIFICANT ISSUES

SB 159 will allow the New Mexico Regulation and Licensing Department to issue a special independent theater dispensing license to an owner or operator of an independent theater, limited to the serving of wine and beer to customers in conjunction with movie screenings or other events. The license fee would be \$100 and would be valid for one year and may be renewed. Service of beer or wine would be limited to two twelve-ounce servings of beer or two six-ounce servings of wine per customer for each event.

This would have no direct impact on the New Mexico Tourism Department.
