Synopsis: Major General Aguilar coordinated on this bill with Senator Padilla who is the sponsor.

The bill is intended to:

- 1. Authorize the Adjutant General to utilize appropriated funds to support and enhance youth programs. This authority includes the discretion to allocate resources as deemed necessary to ensure the effective operation and development of such programs to meet the Governor's intent.
- 2. Create a new section in law to enable the Department of Military Affairs to allow for conducting comprehensive background checks on individuals working with children in our NM Youth ChalleNGe and Job ChalleNGe programs and the Governor's Summer Youth program. This measure is vital to ensure the safety and security of vulnerable populations within the programs administered by the Department of Military Affairs and to comply with state requirements.
