SECTION III: NARRATIVE

BILL SUMMARY

Synopsis:

SB172- In an effort to increase access to quality health care in underserved communities, calls for an acceleration program, physician readiness pathway, and primary care residency grant program for qualified immigrant health care workers. Creates a Fund and Advisory Group. Details of physician licensure procedures. Appropriates \$1.5 million (GF) to the Workforce Solutions Department for use in FY2026 to administer the act, including hiring three full-time-equivalent department staff and providing program grants.

FISCAL IMPLICATIONS

These additional licensing pathways will incur increased time and resources for medical board personnel. Additional funding and resources must be allocated through state appropriations to implement, operationalize, and evaluate any additional pathway for medical licensure.

Insufficient financial resources to support such additional licensing pathways risks inadequate resources and expertise that may lead to rushed or incomplete licensure eligibility decisions, risking the admission of underqualified practitioners or delays in integrating ITPs into the healthcare workforce.

SIGNIFICANT ISSUES

SB 172 addresses an alternate licensure pathway for 2 types of physicians: internationally-trained physicians and foreign medical graduates.

Internationally-trained physicians (ITPs) are usually referred to as <u>physicians</u> educated and trained abroad who must also be licensed and have practiced medicine in another jurisdiction. This cohort of physicians represents a relatively small category of international medical graduates (IMGs), the broader term used to describe physicians who received their medical degree outside the United States. Individuals who are ITPs, in most descriptions, must have previously completed graduate medical education (also known as postgraduate medical education or postgraduate training/ residency training) that is "substantially similar" to that which is recognized in the United States.

IMGs, or international medical graduates, have graduated from a non-US medical school, but have not yet completed a residency program or its equivalent and are not prepared to safely practice medicine in New Mexico without the oversight of standard educational programs such as the traditional residency program offered by the UNM School of Medicine.

ECFMG Certification and graduation from a duly recognized medical school (noted in this bill as from a school approved by the World Health Organization or the World Directory of Medical Schools) should be required for the immigrant primary care physician readiness pathway eligibility. Additionally, the NMMB agrees completion of postgraduate training (graduate medical education which is substantially equivalent to ACGME approved programs) outside the United States should be required.

The NMMB acknowledges there may be difficulty ensuring the postgraduate training is equivalent to the rigorous US standards. Legislation and/or medical board regulations in other states enacting similar legislation only allow applicants with postgraduate training from specific countries.

The NMMB must preserve the authority to assess each candidate for full and unrestricted licensure; additional requirements to confirm successfully completed training may be implemented to ensure licensees are able to provide safe and effective patient care. Rules will be promulgated by the NMMB evaluating licensees following completion of these programs and pathways.
