SECTION III: NARRATIVE

BILL SUMMARY

This bill would create a homelessness reduction division in the health care authority and a position for a Director of Homelessness Reduction to lead that state's comprehensive efforts related to homelessness prevention. The bill prescribes data integration work to support prevention. To assist with governance, the bill outlines requirements for an interagency homelessness reduction task force and the homelessness reduction advisory council.

FISCAL IMPLICATIONS

The funding for the proposed office is \$1M, but the cost to implement effective prevention projects would likely far exceed that allocation.

CONFLICT, DUPLICATION, COMPANIONSHIP, RELATIONSHIP

The functions of the proposed office are duplicative with the Office of Housing Planning and Production (OHPP) that is currently operating in the Office of the Governor. The Governor has requested \$50M to address homelessness through OHPP. Per introduced legislation, the OHPP would be responsible for state-level coordination. Early planning for this work within the Governor's Office has also focused significant attention on prevention.

TECHNICAL ISSUES

OTHER SUBSTANTIVE ISSUES

The bill does not connect affordable housing to homelessness prevention and instead is looking at an interagency taskforce and data integration to prevent homelessness. The data system envisioned to prevent homelessness, the homeless management information system, only contains information for individuals who are currently or have previously experienced literal homelessness, consistent with the HUD definition. The data sources, integration, and management necessary to proactively identify and prevent incidence of homelessness will be significantly more complex and expensive than what is outlined in this bill. ALTERNATIVES

WHAT WILL BE THE CONSEQUENCES OF NOT ENACTING THIS BILL

In the absence of an Office of Housing Planning and Production, this might be a way to focus departments on their potential role in homelessness prevention. However, if the Legislature moves forward with a funded OHPP there will be alternative avenues for these conversations that is also tied to funded initiatives.
