### **SECTION III: NARRATIVE**

#### **BILL SUMMARY**

##### Synopsis:

SB200 Amends Section 12-5-2 NMSA 1978 to add a state holiday to vote on the first Tuesday of November.

#### **FISCAL IMPLICATIONS**

The additional state holiday, while technically not increasing payroll, would make state employees unavailable to constituents and stakeholders for that day.

#### **SIGNIFICANT ISSUES**

#### **PERFORMANCE IMPLICATIONS**

SB200 adds an additional day off to the current 11 paid holidays to state employees to vote.

#### **ADMINISTRATIVE IMPLICATIONS**

#### **CONFLICT, DUPLICATION, COMPANIONSHIP, RELATIONSHIP**

#### **TECHNICAL ISSUES**

The proposed language would be better if simply used the “general election,” that is how the NM election code denotes the federal elections in November.

In that vein, the NM election code also uses a term for “statewide elections” that include the: 1) general election, 2) primary election, 3) regular local election, and 4) an election to fill a vacancy for US Representative. You can expand this holiday to all of these elections by using the statewide election term. See NMSA 1978, Section 1-1-5.12.

#### **OTHER SUBSTANTIVE ISSUES**

The state provides its classified employees with admin leave to vote on election day.

1.7.7.14(C) NMAC states:

“Employees who are registered voters may absent themselves from work for two hours for the purpose of voting between the time of the opening and the time of the closing of the polls. The employer may specify the hours during the period in which the voter may be absent. This leave is not available to employees whose workday begins more than two hours subsequent to the time of opening the polls or ends more than three hours prior to the time of closing the polls. This leave is only available for those elections listed in Subsection A of Sections 1-12-42 and 1-1-19 NMSA 1978 and does not apply to absentee

or early voting.
