### **BILL SUMMARY**

Synopsis: Senate Bill 205 (SB205)

SB205 creates the Office of Housing Planning and Production that is administratively attached to the Department of Finance and Administration. The purpose of SB205 is to create an office that sets housing goals, improves availability of housing for people across the state of New Mexico, and makes housing more affordable for the people of our state, regardless of income.

SB 205 does not directly affect the Regulation and Licensing Department. (RLD).
