## **SECTION III: NARRATIVE**

#### **BILL SUMMARY**

Senate Bill 325 (SB325) directs the Corrections Department to establish and administer a post-secondary education program for an associate's degree in alcohol and drug abuse counseling for qualified inmates across all New Mexico correctional facilities. The bill specifies that Luna Community College grant the degree and New Mexico Highlands University develop the curriculum and provide technical assistance. It appropriates five hundred thousand dollars (\$500,000) from the General Fund (GF, non-reverting) to the New Mexico Corrections Department.

#### FISCAL IMPLICATIONS

SB325 directs the New Mexico Corrections Department to establish and administer a post-secondary education program for an associate's degree in alcohol and drug abuse counseling for qualified inmates across all New Mexico correctional facilities. The bill specifies that Luna Community College grant the degree and New Mexico Highlands University develop the curriculum and provide technical assistance. It appropriates five hundred thousand dollars (\$500,000) from the GF (non-reverting) to the New Mexico Corrections Department in Fiscal Year 2026 (FY26) and subsequent years to establish and administer the program.

This program would be available in all facilities, including those privately operated by contract with the state.

Luna Community College would grant the associate's degree, and New Mexico Highlands University would develop curriculum and provide technical assistance to the New Mexico Corrections Department and Luna Community College for the program's administration. At a minimum, the program must be:

- · accredited by the appropriate regional or national accrediting agency, and
- meet licensing requirements for an alcohol and drug abuse counselor pursuant to the Counseling and Therapy Practice Act.

#### SIGNIFICANT ISSUES

Some items to consider include the following:

- SB325 does not specify whether these programs would be in-person or online.
- SB325 does not specify which institution would provide faculty, oversee courses, and maintain the academic integrity of the program.
- SB325 does not specify which institution would maintain the curriculum over time, amending and updating such curriculum when required by law.
- Luna Community College is currently not approved to grant this degree. Luna Community College must apply through the New Mexico Higher Education Department and be approved to offer an associate's degree in Alcohol and Drug Abuse Counseling.
- Qualified inmates would be required to fulfill the general education requirements for an associate's degree including 31 credits: Communications (6), Mathematics (3), Science (4), Social and Behavioral Science (3), Humanities (3), Creative and Fine Arts (3), Flex (9)
- An associate degree in Alcohol and Drug Counseling requires a minimum of three years
  and three thousand client contact hours under appropriate supervision of experience in the
  practice of alcohol and drug abuse counseling and two hundred hours of face-to-face
  supervision (New Mexico Board of Counseling and Therapy Practices, Rules and
  Statutes, p.34).
