BILL SUMMARY

Synopsis:

Senate Bill 333 (SB 333) is an act that relates to children and enacts the "Children's Benefit Account Act" and provides definitions along with requesting rule adoption. SB 333 requires that the Children, Youth and Families Department (CYFD) be appointed as the representative payee to manage and maintain the Retirement, Survivors and Disability Insurance (RSDI) funds for children in the department's custody. SB 333 also outlines the duties for CYFD to manage the accounts on behalf of the beneficiary and guidance for account closures and disbursements when a child is no longer in the department's custody, along with defining the confidentiality relating to the duties of the department.

- SB 283 offers more specific details about CYFD's responsibilities but lacks the detailed definitions present in SB 333.

Both bills aim to address similar issues but take different approaches in their language and focus. If SB 283 is meant to complement SB 333, it could benefit from clearer definitions to reduce confusion or ambiguity in its implementation.
