#### **SECTION III: NARRATIVE**

#### **BILL SUMMARY**

Creates a specific crime for the assault and battery-related charges of a child welfare worker employed by CYFD in tiered offenses. Does not apply to social workers contracted by but not employees of CYFD. Enhanced penalties are as follows:

- A misdemeanor offense for attempting battery or causing reasonable fear of battery or assault against a state child welfare worker;
- Battery would be a fourth-degree felony;
- Aggravated battery would be a third- or fourth-degree felony, depending on the severity of injury;
- Group battery (battery that included the assistance of others) would be a fourth degree felony;
- Aggravated assault would be a third-degree felony, if using a deadly weapon;
- Assault with intent to commit a violent felony would be a third-degree felony; and
- Assault with intent to kill a state child welfare worker would be punishable as a second-degree felony.

#### SIGNIFICANT ISSUES

The establishment of a specific crime for assault and battery-related charges involving a child welfare worker employed by CYFD is critical in ensuring accountability and protection for both the workers and the vulnerable children they serve. By creating tiered offenses, the law would address varying degrees of harm and misconduct, thereby allowing for proportional punishment based on the severity of the offense.

Child welfare workers often work in high-risk environments, facing challenging and volatile situations while trying to protect vulnerable children and families. The bill would provide an extra layer of protection for these workers by categorizing assaults and batteries against them as specific offenses with clearly defined penalties.

These workers, who are already under significant stress and facing difficult cases, should be afforded additional legal safeguards. By recognizing the risks they face, this bill acknowledges the dangerous nature of their work and helps deter violent acts against them.

The bill increases penalties for various levels of assault and battery against child welfare workers, ranging from misdemeanors to third-degree felonies. These enhanced penalties act as a deterrent for individuals who might otherwise consider committing violence against these public servants. The potential for serious legal consequences could reduce such crimes.
