### Synopsis:

SB 337 clarifies pension earned for Commissioners appointed on or after January 1, 2023, noting, the amount of pension under form of payment A is equal to two and one-half percent of the final average salary multiplied by service credit. The amount shall not exceed one hundred percent of the final average salary.
