SECTION III: NARRATIVE

BILL SUMMARY

Synopsis:

SB409 amends section 12-5-2 NMSA 1978 to add "Football Monday", the second Monday in February, as a legal holiday in addition to the other 11 days currently designated as state holidays. Notably, SB409 would establish a legal holiday on two Mondays in February.

FISCAL IMPLICATIONS

The FY26 budget would not be directly impacted by the additional pay for state workers for the holiday. The estimated current cost for the holiday based on 23,746 employees would be \$6,646,935 for 8 hours, including benefits.

SIGNIFICANT ISSUES

State classified employees observe the 11 holidays currently contained in 12-5-2 NMSA 1978, Adding Football Monday would be the 12th paid holiday for public employees.

SB409 would establish a legal holiday on two Mondays in February. Of note, while President's Day is a paid holiday, it is observed on the Friday following Thanksgiving as approved by the State Personnel Board per 1.7.6.9.

"Football Monday" would be the only state holiday that is not also a federal holiday.
