### Synopsis:

SJR 2 proposes an amendment to Article 20 of the Constitution of New Mexico by adding in a new section prohibiting the expenditure or encumbrance of trust funds created through the Retiree Health Care fund for any purpose except for the sole and exclusive benefit of the trust beneficiaries.

## **TECHNICAL ISSUES**

The language of the Joint Resolution resembles the existing constitutional provision relating to the public employees retirement system and the educational retirement system. However, the Joint Resolution does not include the following language that is included in Section XX, Article 22 of the New Mexico Constitution: "The legislature shall not enact any law that increases the benefits paid by the system in any manner or changes the funding formula for a retirement plan unless adequate funding is provided."
