**MAKING AN APPROPRIATION TO CONTRACT FOR SERVICES TO THE DONA ANA
COUNTY SHERIFF FOR A PILOT JUVENILE GANG INTERCEPTION AND
SURVEILLANCE PROGRAM**

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- One hundred eighty thousand dollars (\$180,000) is appropriated from the general fund to the local government division of the department of finance and administration for expenditure in fiscal year 1997 for the purpose of contracting for services to the Dona Ana county sheriff for a pilot juvenile gang interception and surveillance program. Any unexpended or unencumbered balance remaining at the end of fiscal year 1997 shall revert to the general fund.
