AN ACT

MAKING APPROPRIATIONS TO EXPAND THE NURSE DISTANCE
EDUCATION PROGRAM, THE PRIMARY CARE PHYSICIAN ASSISTANT
TRAINING PROGRAM AND THE LOCUM TENENS PROGRAM AT THE
UNIVERSITY OF NEW MEXICO.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATIONS.--

A. The following amounts are appropriated from the general fund to
the board of regents of the university of New Mexico for expenditure in fiscal year
1997 for the following purposes:

(1) three hundred one thousand one hundred dollars (\$301,100)
for operational costs associated with expansion of the nurse distance education
program;

(2) two hundred fifty-four thousand dollars (\$254,000) for
operational costs associated with expansion of the primary care physician assistant

(3) one hundred thousand dollars (\$100,000) for operational costs associated with expansion of the locum tenens program to provide temporary substitutes for rural physicians.

B. Any unexpended or unencumbered balance remaining at the end of fiscal year 1997 shall revert to the general fund.
