AN ACT

MAKING APPROPRIATIONS TO THE DEPARTMENT OF HEALTH TO PROVIDE OR
CONTRACT FOR PROGRAMS AND SERVICES FOR PERSONS WITH BRAIN INJURIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATIONS.--

A. Five hundred seventy thousand dollars (\$570,000) is appropriated from the
general fund to the department of health for expenditure in fiscal year 1997 to provide or
contract for programs and services for persons with brain injuries in the following amounts for
the following purposes:

(1) four hundred thirty-five thousand dollars (\$435,000) for case
management services; and

(2) one hundred thirty-five thousand dollars (\$135,000) for a life
skills training program and services.

B. Any unexpended or unencumbered balance remaining at the end of fiscal
year 1997 shall revert to the general fund.
