AN ACT

MAKING AN APPROPRIATION FOR PROMOTION, MARKETING ASSISTANCE AND  
DISSEMINATION OF INFORMATION TO LOCAL FARMERS' MARKETS  
STATEWIDE; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION--REPORTS. --

A. Seventy-five thousand dollars (\$75,000) is  
appropriated from the general fund to the economic development  
department for expenditure in fiscal years 1996 and 1997 for the  
purpose of promoting local farmers' markets throughout the state  
and to disseminate educational, nutritional and food-safety  
information to local farmers' markets. Any unexpended or  
unencumbered balance remaining at the end of fiscal year 1997  
shall revert to the general fund.

B. In providing marketing, promotional and farm-

1 direct marketing assistance to local farmers' markets, the  
2 economic development department shall require an annual report  
3 from each farmers' market organization. The report shall  
4 demonstrate the extent to which the market provides information  
5 to nutritionally at-risk families and how the market's efforts  
6 have increased consumer awareness of farmers' markets and farm-  
7 direct marketing possibilities.

8 Section 2. EMERGENCY.--It is necessary for the public  
9 peace, health and safety that this act take effect immediately.
