A. Six million five hundred thousand dollars (\$6,500,000) is appropriated from the general fund to the department of health for expenditure in fiscal year 1997 to provide or contract for the following purposes in the following amounts:

(1) two million dollars (\$2,000,000) to expand the mental health in the '90s program, including expansion to communities with a small population of mentally ill persons, for individualized services for additional seriously disabled mentally ill persons;

(2) one million dollars (\$1,000,000) to provide or contract for residential support services for seriously disabled mentally ill persons, including:

(a) services to communities with small

populations of mentally ill persons;

(b) planning and accessing housing;
