AN ACT

MAKING AN APPROPRIATION TO EXPAND AND ENHANCE PROGRAMS AT THE
SUSTAINABLE AGRICULTURAL SCIENCE CENTER IN ALCALDE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --

A. Five hundred thousand dollars (\$500,000) is appropriated from the general fund to the board of regents of New Mexico state university for expenditure in fiscal year 1997 to expand and enhance programs at the sustainable agricultural science center in Alcalde. The appropriation shall be distributed in the following amounts to the following entities:

(1) four hundred four thousand seven hundred eighty-five dollars (\$404,785) to the cooperative extension service; and

(2) ninety-five thousand two hundred fifteen
