AN ACT

MAKING AN APPROPRIATION TO THE STATE DEPARTMENT OF PUBLIC EDUCATION TO PROVIDE A FAMILY SUPPORT PROGRAM AT WILSON MIDDLE SCHOOL IN BERNALILLO COUNTY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION.--One hundred sixty thousand dollars (\$160,000) is appropriated from the general fund to the state department of public education for expenditure in fiscal year 1997 for the purpose of contracting for services to provide a family support program that is located at Wilson middle school and also serves Whittier, Emerson and Kirtland elementary schools in Bernalillo county. The family support program shall include elements that address communication and listening skills, conflict resolution skills, problem-solving skills, decision-making skills, parenting skills and alcohol and drug

education. Any unexpended or unencumbered balance remaining from this appropriation at the end of fiscal year 1997 shall revert to the general fund.
