AN ACT  
MAKING AN APPROPRIATION TO FUND PLANNING AND IMPLEMENTATION OF THE  
JUNE 1996 WORLD INDIGENOUS PEOPLES' CONFERENCE ON EDUCATION IN  
ALBUQUERQUE; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION.--Seventy-five thousand dollars (\$75,000) is appropriated from the general fund to the New Mexico office of Indian affairs for expenditure in fiscal years 1996 and 1997 for the purpose of funding the planning and implementation of the June 1996 world indigenous peoples' conference on education in Albuquerque. Any unexpended or unencumbered balance remaining at the end of fiscal year 1997 shall revert to the general fund.

Section 2. EMERGENCY.--It is necessary for the public peace, health and safety that this act take effect immediately.
