AN ACT

MAKING AN APPROPRIATION FOR PURCHASE AND INSTALLATION OF  
EQUIPMENT AND FURNISHINGS IN THE NEW OTERO COUNTY COURTHOUSE;  
DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --Thirty-two thousand two hundred  
dollars (\$32,200) is appropriated from the general fund to the  
local government division of the department of finance and  
administration for expenditure in fiscal years 1996 and 1997 for  
the purpose of purchasing and installing equipment and  
furnishings in the new county courthouse in Alamogordo in Otero  
county. Any unexpended or unencumbered balance remaining at the  
end of fiscal year 1997 shall revert to the general fund.

Section 2. EMERGENCY. --It is necessary for the public  
peace, health and safety that this act take effect immediately.
