AN ACT

MAKING AN APPROPRIATION TO PROVIDE AN ADDITIONAL DISTRIBUTION TO LOCAL SCHOOL DISTRICTS USING MULTITRACK, YEAR-ROUND SCHOOL CALENDARS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --Six hundred thousand dollars (\$600,000) is appropriated from the general fund to the state department of public education for expenditure in fiscal year 1997 for the purpose of making distributions to local school districts using multitrack, year-round school calendars. Money shall be distributed equally on the basis of the number of students attending schools using multitrack, year-round calendars at a rate of twenty-five dollars (\$25.00) per student, with a maximum of one hundred thousand dollars (\$100,000) per school. Any unexpended or unencumbered balance remaining at the
