AN ACT

MAKING AN APPROPRIATION TO TRAIN OR HIRE EMERGENCY MEDICAL
TECHNICIANS IN THE JEMEZ VALLEY IN SANDOVAL COUNTY; DECLARING AN
EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --Sixty thousand dollars
(\$60,000) is appropriated from the general fund to the
department of health for expenditure in fiscal years 1996 and
1997 for the purpose of training, if necessary, and hiring two
additional licensed emergency medical technicians to be
stationed at the pueblo of Jemez to respond to emergency medical
needs of Jemez valley residents. Any unexpended or unencumbered
balance remaining at the end of fiscal year 1997 shall revert to
the general fund.

Section 2. EMERGENCY. --It is necessary for the public
