- (5) coordinates all federal and state efforts regarding the school-to-work system, provides development and training and encourages procedures for participation in the school-to-work system; and
- established and supported in school districts and communities by emphasizing and encouraging job training, job placement, mentoring services, community involvement by students, career counseling and placement and the integration of academic and vocational education, as well as student employment with community businesses to encourage continuing education and skills development.
- B. Any unexpended or unencumbered balance remaining at the end of fiscal year 1997 shall revert to the general fund.
